

APPLICATION FOR APPOINTMENT TO PULLMAN PUBLIC SCHOOLS BOARD OF DIRECTORS TO FILL A VACANCY

Thank you for your interest in serving the community as a member of the Pullman School District Board of Directors. The quality of our schools is the result of the many strong partnerships that exist among families, students, community agencies and organizations, and the high value the whole community places on quality education for all its children and youth. Pullman School District offers the most comprehensive academic programs in the region and many opportunities for children to extend classroom learning through curricular and co-curricular enrichment. In the Pullman School District, our primary focus is each student's learning. You are invited to visit the district website at www.pullmanschools.org, as well as each of our school websites to learn about our programs.

The current board vacancy is a position representing **Director District #1**. Remaining board members will appoint a qualified person to serve until the term for this position ends. The term for this position ends at the first official meeting of the school board that follows the certification of the November 2023 elections.

Board Member Eligibility, Requirements & Public Disclosure

To be eligible for appointment to the Pullman School Board in Director District #1

- You must reside within the Director District of the vacant seat (https://www.pullmanschools.org/school_board/school_board_-_district_map); and
- You must be eligible to vote (https://www.sos.wa.gov/elections/voters/voter-eligibility.aspx).

If you hold, participate in, or are involved in any contract(s) with the Pullman School Board or the district, please explain your involvement in your cover letter. If you hold any other elected public office, please state what office and where in your cover letter.

Please note that:

- Once a board member application is filed with the district, it is a public record available to the public.
- The applications received from all candidates who meet the minimum requirements of state law, along with the answers to the application questions, will be posted on the Pullman School District website as part of the board's meeting agenda prior to the initial interviews.

If appointed, you will be required by state law to file financial disclosure statements with the Washington Public Disclosure Commission (www.pdc.wa.gov).

The timeline for filling the school board member vacancy is as follows:

Board candidate applications available online: January 12, 2023 Applications due to Superintendent's Office: February 10, 2023

Candidate interviews: Week of February 27, 2023

Board member selection and appointment: March 8, 2023 Regular Board Meeting

New board member sworn in at regular board meeting: March 22, 2023

Board Member Duties & Compensation

The Pullman School District is governed by a five-member Board of Directors. Board members are elected from specific geographic areas of the district, but the board works as a body to serve the district at large. The superintendent reports to the school board and leads the day-to-day operations of the district. The school board does not supervise or evaluate any staff members other than the superintendent. The Pullman School District has approximately 2,650 students and employs approximately 385 people, both certificated and classified. The General Fund budget for the 2022-2023 school year is \$43.4 million.

The duties of a school board member will likely involve an average minimum commitment of 10-15 hours per month for preparation, participation, and attendance at meetings.

- Attendance is required at regular board meetings, which are typically held on the second and fourth Wednesday evenings of each month, at 6:30 p.m. Attendance is also required at a daylong Annual Board Retreat in July.
- School board members have school site visits (including commencement proceedings), occasional special
 meetings, and closed/executive sessions. Members also represent the school board at various school-related
 and community functions.
- School board members also may participate in meetings and conferences with the Washington State School Directors Association (WSSDA). Attendance is strongly encouraged at the Annual WSSDA Conference, typically held each November.
- School board meeting agendas with supporting documentation, voting, and policies and procedures are managed through an online web-based system providing paperless distribution and management.

Pursuant to Board Policy and Procedure 1105-1115, the Board of Directors of the Pullman School District shall consist of five members elected by ballot by the registered voters of the district.
